The court of appeal, which at the time I was scheduled to write opening brief refused to list the parties to the appeal, claiming that LA Superior Court was not a party and would not appoint a counsel and would not respond to any brief, finally produced picture perfect records months after the fact, for the permanent record.

But even here:

The forms state Judgment Date instead of Entry of Judgment Date.

The “Judgment Date” appears only in the final appeal, but none of the previous records. There too, it appeared only in summer 2008, a year after the purported Judgment Date, and months after Keshavarzi refused to enter a judgment date in his cross appeal.

Party designation is still fluid, and Pasternak and Samuels are “Other” in the final appeal.
